RETENTION / UPGRADATION OF IHM AGAINST FIRST ALLOTMENT AND FRESH ALLOTMENT UNDER SECOND ALLOTMENT TO FILL VACANCIES

Instructions:

- Allotment shown in the list is provisional.
- Retained / Upgraded candidates are required to report to the allotted IHM as their first semester fee of Rs.43,000/- already received by this Council.
- Fresh allotted candidates are required to accept the offered seat by uploading the documents by clicking the link given below.

In case the Graduation certificate is not available or result awaited, an Undertaking has to be furnished by the candidate stating that the Graduation certificate will be produced latest by 30.11.2020. Format of the undertaking is also made available in the above link, printout of which may be taken and upload the signed undertaking by scanning.

After verification of the documents by the authorities of concerned Institute, you will receive an e-mail from the Institute for depositing the first semester fee of Rs.43,000/- (Rs.40000 course fee; Rs.1000 enrollment fee and Rs.2000 examination fee). This fee is exclusive of IGNOU Fee of Rs.10,000 which will be paid by the candidate at the time of registration with IGNOU. The fee of Rs.43,000 has to be deposited into NCHMCT's account through RTGS/NEFT as per account details provided to you in the mail. Thereafter, you have to upload the fee details in the link given in the said e-mail.

- As notified in the Information Brochure of M.Sc. JEE 2020, Institutes located at 'A' Category cities i.e. Bengaluru, Chennai, Kolkata, Pusa (New Delhi) and NCHM-IH Noida have the discretion to charge 25% extra on course fee component only. Whereas, IHM located at 'B' Category cities i.e. Lucknow is having the discretion of charging 15% extra on course fee component only. Accordingly, after paying Rs.40,000 course fee as above, differential fee, if any, will have to be paid by the candidates at the allotted Institute directly.
- Last date for uploading the documents for verification and transfer of fee into NCHMCT's account in case of Fresh Allotment candidates is **24th October 2020 till 8.00 PM.**
- Allotment of Institute is final. Request for change of allotted IHM will not be entertained by this Council.
- Withdrawal of admission after paying fee by the Fresh Allotted candidates will not be considered for refund as this is final allotment.

- Caution money, library fee, locker fee, etc. will be charged extra by the Institutes which will be very minimal and to be paid directly to the Institute.
- Candidates are advised to collect details of hostel/mess charges, which will be paid directly to the concerned Institute
- Schedule of online classes will be communicated to candidates by respective Institutes.
- At the time of reporting for physical classes at the allotted IHM, candidates will have to furnish all original certificates for verification in support of eligibility.
- Candidates those who have furnished an Undertaking regarding submission of Graduation certificate by 30.11.2020 and fail to do so by the prescribed date, their admission will be cancelled and no refund of fee will be made except caution money, if paid in the Institute.
