1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. 3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
4. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any

Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

- National Council For Hotel Management & Catering Technology, Noida intends to select a registered and a reputed firms/companies to provide Packaged Drinking Water services to NCHMCT, Noida.

Instruction To Bidder

- NCHMCT expects the bidder to comply with the tender specification/ conditions. The bidders not complying with the terms & conditions of the tender and offers indicating exceptions / deviations may be rejected without seeking any clarification.

Scope of Work

1. Packaged drinking water of clean, pure and good quality without any bad odor or taste should be supplied.
2. Packaged drinking water should be supplied in 20 litre cans of Bisleri and equivalent brands only.
3. The cans in which water supplied should be clear, clean, sealed, not yellow, not muddy, not damaged, without leaks..
4. The water supplied should be well within the best before date or expiry date.
5. Approximate quantity required is 20 cans per day. However due to seasonal and climatic conditions and during any events at Office the required quantity may vary.
6. The delivery should be completed before 10 AM or within 01 hour of this Office's request on all working days based on the actual demand.
7. If the need arises, the delivery should also be done on public holidays without any extra cost.
8. The service shall be delivered at NCHMCT, A-34, Gautam Buddh Nagar, Sector-62, Noida, UP-201309.
9. Director(A&F), NCHMCT reserves the right to test the water sample at any laboratory and in case of contaminations found in the supplied drinking water that leads to health disorders; Director(A&F), NCHMCT reserves the right to take legal action under appropriate clause as per the existing guidelines.
10. The TDS level should be 150 ppm to ensure the health and safe drinking water.

Essential Technical Eligibility Criteria:

1. Should have a valid GST certificate.
2. Should have an experience of at least one year in the relevant service and the supporting documents should be uploaded.

Other Important Terms & Conditions:-

1. The contract will be for a period of One year and may be extended for further period(s) (upto three years) with same terms & conditions subject to satisfactory service or as may be required and on mutually agreed Terms & Conditions.
2. Bidder shall not sublet any part of the Contract.
3. Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.
4. Payment shall be made on monthly basis through NEFT/RTGS within 15 working days on receiving the bills/invoices TDS and other taxes will be applicable as per government rules.
5. NCHMCT will have option to terminate the contract if the bidder commits the breach of any of the conditions confined in this contract and fails to render the services to the satisfaction of NCHMCT after giving notice of one month expressing its intention to terminate the contract.
6. In case the bidder fails to deliver the cans for any particular day or as per the request of this Office, the expenditure incurred to this Office for the purchase of the same will be recovered from the next bill of supply.
